High concentrations may exclude oxygen and cause dizziness and suffocation. Contact with liquid or cold vapor may cause frostbite or freeze burn. Exposure to concentrations above 10% of the LEL may cause a general central nervous system (CNS) depression typical of anesthetic gases or intoxicants. Aliphatic hydrocarbon gases may build up in confined spaces and may cause dizziness, light-headedness, headache, nausea and loss of coordination. For large fire the use of unmanned hose holders or monitor nozzles may be advantageous to further minimize personnel exposure. Isolate area, particularly around ends of storage vessels. Withdraw immediately in the event of a rising sound from a venting safety device. Large fires typically require specially trained personnel and equipment to isolate and extinguish the fire.

### **SECTION 6. ACCIDENTAL RELEASE MEASURES**

Personal precautions	:	Evacuate nonessential personnel and remove or secure all ignition sources. No road flares, smoking or flames in hazard area.
