# Section 3 - Hazards Identification

\*\*\* Emergency Overview \*\*\*: Harmful if inhaled. May affect the brain or nervous system causing dizziness, headache or nausea. Harmful if swallowed. Causes eye irritation. Vapors irritating to eyes and respiratory tract. Combustible liquid and vapor.

Effects Of Overexposure - Eye Contact: Causes eye irritation.

Risk of overexposure depends on duration and level of exposure to dust from repeated sanding of surfaces or spray mist and the actual concentration of Titanium Dioxide in the formula.

Reports have associated repeated and prolonged occupational overexposure to solvents with permanent brain and nervous system damage. Overexposure to xylene in laboratory animals has been associated with liver abnormalities, kidney, lung, spleen, eye and blood damage as well as reproductive disorders. Effects in humans,

## Section 4 - First Aid Measures
